

# END USER LICENSE AGREEMENT TRIAL LICENCE

**By accessing our services and/or downloading or using our Font Software for the purposes described herein, you agree to be bound by the terms of this agreement (“Agreement”).**

**By downloading and/or using our Font Software on behalf of a business, you acknowledge and agree that you are entering into these terms on behalf of that business and represent and warrant to us that you have full authority to enter into this Agreement on behalf of that business.**

**PLEASE NOTE:** This Agreement incorporates by reference all of the terms set out in our **‘General Terms’** that can be found here . By ticking the box during the order process, you confirm you have read and agree to those terms as part of this licence agreement. If there is any conflict between the General Terms and these terms, these terms shall prevail.

If you do not agree to the terms of this Agreement, you must not use our Font Software.

## **KEY DEFINITIONS:**

The following key definitions will apply to this Agreement:

**“Font Software”** means the software or instructions which, when used on an appropriate device or devices, generates the typeface and typographic designs and ornaments relating to the typeface identified in the Sales Receipt;

**“Sales Receipt”** means the sales receipt containing key details of the Font Software and other relevant information to which this Agreement relates, as issued by us to you following you entering into this Agreement;

**“Workstation”** means a single portable, or non-portable, hardware device capable of installation of .OTF and/or .TTF file formats of the Font Software and via which you are able to give commands that are followed by the Font Software.

## **1. SCOPE OF LICENCE**

### **1.1 TRIAL LICENCE GRANT**

Subject to your ongoing compliance with the terms of this Agreement (and without prejudice to any other right of termination as set out herein), we hereby grant to you a non-exclusive, non-transferable, limited licence to install the Font Software on one of your Workstations solely for the purpose of privately assessing the performance, quality, and suitability of the Font Software by producing digital documents incorporating the Font Software (“Trial Licence”) .

We may terminate this trial licence at any time by giving you written notice. In the event that such notice is given, this Trial Licence shall automatically terminate 14 days after such notice is given.

## 1.2 RESTRICTIONS

By downloading and/or using our Font Software, you undertake to us to not:

- publish any documentation or other materials resulting from, incorporating or demonstrating any use of the Font Software;
- print any documentation or other materials resulting from, incorporating or demonstrating any use of the Font Software (unless the same is necessary for the purpose of internally assessing the performance, quality, and suitability of the Font Software);
- embed the Font Software in any documents, applications, devices, or other materials in any other form (e.g. as a subset of the Font Software or as raster images such as GIF, JPEG, etc.);
- copy, alter, modify, combine, convert, rent, sublicense, merge or otherwise transfer, distribute or sub-licence the Font Software; and
- otherwise use the Font Software in any manner inconsistent with our General Terms [LINK].

## 2. USAGE BEYOND THE SCOPE OF THIS LICENCE

Any of the following uses of the Font Software are beyond the scope of this Agreement and will require an additional licence to be purchased:

- use on any website;
- use in connection with the creation or publication of e-books;
- use in apps (applications that can be installed on mobile operating systems);
- use in editable documents to be distributed to third parties;
- use in any kind of moving image;
- use in connection with broadcasting, transmitting, streaming, or otherwise airing (e.g. exhibition or display in cinemas, motion pictures, on television or on cable television, etc.);
- use as a logo or trade mark (whether registered or unregistered);
- embedding of the Font Software within hardware equipment or the operation system of an electronic device (e.g. an e-book reader, a mobile operating system, etc.) or software;
- transmitting the Font Software to third parties via the internet or otherwise;
- use on products you sell (including as or within software products);
- use on or in documents or material that are to be made available via social media channels.
